Tamara Adrián is a Venezuelan lawyer and graduated from the Andrés Bello Catholic University in Caracas. She further obtained a Doctorate in Law degree at Paris 2 University and a Diploma in Comparative Law from the Paris Institute of Comparative Law. She is a professor at the Andrés Bello Catholic University (retired), Central University and at the Metropolitan University of Venezuela, covering torts and contracts, commercial law, corporations, capital markets, international contracts, consumers' law and general theory of law. She is the author of many articles and books relating to the matters she teaches, as well as LGTTTBI law. Her works have been published in Venezuela, Colombia, France, the United States, Holland, Peru and other countries. She is the President for the Committee of the International Day Against Homophobia

and Transphobia. She is the female Co-President of the Gay, Lesbian, Trans, Intersex Sport Association, organisers of the World Outgames. She is the President of the Board of Directors of Global Action for Trans Equality and a member of the Scientific Committee for the UNESCO Chair on Sexual Health and Human Rights. She is member of the Board of Directors of WPATH, and PLAFAM.

Zhan Chiam – Gender Identity and Gender Expression Senior Programme Officer, ILGA Europe

Zhan Chiam is ILGA's Programme Coordinator (Gender Identity and Expression, Sport and Human Rights), where he works to strengthen trans movements through advocacy support, movement building, research, and longterm collaborations such as reform of the International Classification of Diseases. INJUSTICE EXPOSED: THE CRIMINALISATION OF TRANSGENDER PEOPLE AND ITS IMPACTS

The Human Dignity Trust's latest publication is the first global report of its kind on the criminalisation of trans and gender diverse people.

Key findings:

- Abuse reported by trans and gender diverse people includes blackmail, extortion, public humiliation, and physical and sexual violence. This occurs all over the world in countries where there are laws that are used to criminalise them, and in countries without such criminalising provisions.
- In at least 26 countries, 'public order', 'vagrancy' and 'misdemeanour' offences are used to criminalise trans people. At least 15 jurisdictions around the world criminalise the gender expression of trans and gender diverse people, through 'crossdressing', 'impersonation' and 'disguise' laws.
- In multiple studies from the Americas, Africa and Asia, overwhelming majorities of trans and gender diverse people experience harassment, violence and abuse from state officials, and identify them as the main perpetrators of their discrimination.

David qualified in 1980, becoming a senior partner at Edwin Coe in 2011. He is a litigator and claimants' practitioner and has specialised in group claims for over 25 years in the UK and the USA, with a focus on commercial claims. Téa is a member of the Law Society of British Columbia and holds an LLM in International Human Rights Law from the University of Essex where she was named Alumna of the Year 2014 for services to human rights. She is a Strategic Advisor to the global Equal Campaign which promotes gender parity in international tribunals and was a member of the Executive Committee of the Commonwealth Lawyers Association from 2015-2017.
